April 30, 2018

New Business – Discussion Item

Proposed Administrative Staffing Changes: Dr. Piazza said that when she took the position of Superintendent, she was charged to assess and analyze the district's current status of operations, from business & fiscal operations to the academic, curricula and instructional practices currently being implemented. Together with the administrative team, the District's data trends were analyzed and an in- depth root cause analysis was conducted. Based on their assessment of the analysis and working extensively with the entire leadership team, she has learned their areas of strength as well as their passions. Dr. Piazza said that it is with these areas of strength in mind that she would like to propose a restructuring of the Administrative team.
